Landfill gas	0.63 %	Carbon Dioxide (CO ₂) is released when certain fuels are burned. It is considered a greenhouse gas and a major contributor to global warming.		
Liquid biofuels	0.18 %	Nitrogen Oxides (NO _x) form when certain fuels are burned at high temperatures. They are considered contributors to acid rain and ground-level ozone (or smog).		
Municipal solid waste	0.42 %	Sulfur Dioxide (SO ₂) is formed when fuels containing sulfur are burned. Major health effects associated with SO ₂ include asthma, respiratory illness, and aggravation of existing cardiovascular disease.		
Natural Gas	39.72 %	The production of electricity can produce other harmful emissions and have other environmental impacts. Environmental impacts differ among individual power plants.
