Terms of Roll-out

- The "Removal Date" for the/each Roll-out Site for the purpose of the Agreement is set out below.
- The Roll-out Site/s will cease to be a "Site" for the purposes of the Agreement from the Removal Date. The Removal Date must be at least 25 Business Days from the date of this notice.
- Notwithstanding anything else in this notice, if a Roll-out Site is removed from the Agreement during the Notice Period, the Customer must continue to pay any charges in accordance with clause 8.1(c) of the Agreement.
