- The Customer acknowledges that this notice does not amend Schedule 2 of the Agreement. SmartestEnergy may issue a separate notice under clause 8.3 of the Agreement updating Schedules to the Agreement for the Roll-in Sites.
- The Customer acknowledges that the estimated consumption set out in this notice:
  - is not included in any calculations of the “Forecast Consumption” under the Agreement;
  - is not included in any calculations of “Maximum Load for Sites” and “Minimum Load for Sites” under the Agreement; and
  - is not included in any calculations of “Forecast Load Profile” under the Agreement.
- SmartestEnergy retains the right to charge Consumption Variation Charges and adjust any charges in accordance with clauses 7.2 and 7.4 of the Agreement.
- The Customer represents and warrants to SmartestEnergy that the information provided by the Customer in this notice is true, accurate and complete.
- The Customer agrees to give SmartestEnergy notice if it becomes aware of any likely material change in the information provided in this notice.

**Terms of Roll-In**

- The “Expected Commencement Date” for the/each Roll-in Site for the purpose of the Agreement is set out above.
- The Roll-in Site/s will commence to be a “Site” for the purposes of the Agreement from the Expected Commencement Date. The Expected Commencement Date must be at least 25 Business Days from the date of this notice.
- The Customer acknowledges that if SmartestEnergy has not become Financially Responsible under the Rules for each of the Customer’s Connection Points for each of the Roll-in Sites on or prior to the Expected Commencement Date set out in this notice, it may charge the Customer Delayed Financial Responsibility Charges in accordance with clause 5.2 of the Agreement.

If executing this form on behalf of the Customer, you warrant that you are duly authorised to act on the Customer’s behalf.
