Our Deemed Tariff - Explained

Our Deemed tariff applies if you move into premises where SmartestEnergy Business is the existing electricity supplier and you have not agreed contracted rates. In these circumstances, and in accordance with our Terms and Conditions, you will automatically be supplied under a deemed agreement and billed on our Deemed tariff.

If you're an existing customer and cancel your Direct Debit instruction, or if payment is not received, your account may be moved to our Deemed tariff. Where possible, we will notify you in advance of any change and explain the steps you can take to avoid being placed on the Deemed tariff.

Please note: Prices are for guidance only and may be subject to change in accordance with our standard terms and conditions. All prices shown exclude Climate Change Levy and VAT, which will be charged at the prevailing rate.
